Legal Alert - Installation of the National Anti-Corruption Mechanism

On June 9th 2022, VCA published a Legal Alert regarding the new obligations in Compliance and Prevention

and Repression of Corruption following the implementation of two legislative diplomas of the utmost

importance, the Decree-Law n. 9109-E/2021, of December 9th and Law n. 93/2021, of 20/12.

Because of the implementation of this legislation, the Ministerial Order no. 164/2022 of June 23rd and the

Resolution of the Council of Ministers no. 56/2022 of July 5th 2022 were published in the Diário da

República, with the aim of regulating and concretely implementing the measures foreseen in the National

Anti-Corruption Strategy, approved by the Resolution of the Council of Ministers no. 37/2021 of April 6th.

Ministerial Order no. 164/2022, of June 23rd 2022

• Ministerial Order 164/2022 of June 23rd regulated the establishment of the National Anti-Corruption

Mechanism (MENAC), an independent administrative body whose mission is to promote transparency

and integrity in public action and to ensure the effectiveness of policies to prevent corruption and

related infractions;

• Until its definitive location, MENAC will work in installations allocated to the Ministry of Justice, and

will have the support of human resources from Senior Technicians from the General Secretariat of the

Ministry of Justice and the General Secretariat of the Ministry of Finance, who will prepare the project

of MENAC's Internal Regulation, as well as providing the other support considered necessary by its

President;

The MENAC's operating costs will be covered by the General Secretariat of the Ministry of Justice until

it has its own budget, to be included in the State budget for general expenditure;

The definitive location of MENAC will be declared by joint decree of the Ministers of Justice and

Finance, on the proposal of its President, as soon as MENAC has a budget allocation that covers its

operating expenses, its governing bodies¹ have been set up and at least half of the posts on the

monitoring commission and its staff map have been filled, which should be before June 2023².
