

# Legal Alert - Amendments to the office employees' mandatory minimum working conditions

It was published on September 1, 2022, the **Government Order No. 218/2022** which amended Government Order No. 182/2018 on the working conditions for office employees not covered by specific collective bargaining agreements.

We underline that the Order's scope of application is limited to employers and office employees at their service that operates in sectors or business areas in which there is no employers' association(s) with which the unions may execute collective bargaining agreements. The Order is solely applicable on Portugal's mainland.

We highlight the following changes:

**Meal Allowance:** employees are entitled to a meal allowance in the amount of  $\in$  5.45 for each full day of work.
